By virtue of the provisions of Section 4 of the Securities and Future Act 2001, the aforesaid companies are deemed to have an interest in the issued ordinary shares in the capital of the Company ("Shares") held by HF Land.

Each of HF Land Asia and HFLIL is deemed interested in the 295,500 Shares held directly by Allied Crown Limited ("ACL") as ACL is a wholly owned subsidiary of HF Land Asia, which is in turn a wholly owned subsidiary of HFLIL.
