



- Health and safety of employees, tenants and guests are our top priorities
- Proactively implemented series of precautionary measures:
  - Temperature Scanning
  - Safe Entry QR Code
  - Safe Distancing





### **UPDATE ON COVID-19 IMPACT**

#### Outlook and Impact on our properties for FY2020

- YOTEL Singapore Orchard Road
  - Operations adversely affected due to the implementation of Circuit Breaker
  - Not expected to return to normalcy anytime soon with the travel restrictions and border controls remain in place
- International Building and The Concourse
  - Committed to fully passing on property tax rebates to eligible tenants
  - Rental in FY2020 stable so far but may face uncertain economic outlook
- Concourse Skyline
  - Sales of residential units will be adversely affected

#### **CESSATION OF QUARTERLY REPORTING**

- On 16 March 2020, the Group announced that with effect from this financial year ending 31 December 2020 (FY2020), it will adopt half-yearly announcements instead of quarterly announcements
- Accordingly for FY2020, the next financial results announcement will be for the half-year ending 30 June 2020
